OSU Extension Program Coordinator - Gail Langellotto

Gail has added three new courses to the Elevated Skills Training for Master Gardeners. 502 Master Gardeners have enrolled. Courses designed for the general public are filled to capacity. 52 applications have been submitted for the Diversity, Equity, and Inclusion Learning Community and Cohort. Treasurer's Report - Patrice Sipos

January reported no significant expenditures in January. Eric Bosler indicated he has billings for Mini-College and will forward them to Patrice. One bill is the annual \$20 fee to maintain the domain name for the Mini-college. Donations from chapters and individuals totaled \$291 for January. The YTD net income is (\$411.51). Total Current Assets are \$70,652.61. Patrice is working on year-end reports and gathering information for the CPA. The fee for the CPA should be less as no chapter earned over \$50,000 in 2020. Patrice had problems using the debit card and will meet with bank representatives to resolve the issue.

Database/List Serve - Seamus Ramirez

Seamus is updating the OMGA list of state/county officers and OSU MG Program Contacts. The update should be complete in another week. He set up the new email address for the plant sale chairs/committee members.

Mini-college Report - Sue Nesbitt

- Rich Taylor spoke to a member of the Corvallis Assistance League. They use "32 Auctions" for their silent auction. There is a set-up fee based on the number of items as well as transaction fees of +/-\$7.00 per \$100.00. There are additional charges for upgrading features used on the auction website. Visit <u>32auctions.com</u> to view the website and the options available. Discussion on shipping/delivering auction items included: (1) Ask for easily shipped items, (2) Offer gift certificates, (3) Have regional centers for delivery/pick-up, (4) Charge a shipping fee, (5) have donators ship the items.
- Other suggestions: each chapter donate \$250.00 in place of items; reduce the amount from each chapter to \$200; to ask for cash from chapter and not have a Silent Auction.
 The Min-college committee will present a proposal at the March 5th OMGA Board Meeting.
- To fill break time between the meetings, the Mini-college committee is considering slide shows of award winners and of Oregon gardens to fill the time between meetings.
- Eric noted that Mini-college is looking for an MC as well as 7 moderators for each day.
- Amy indicated she can have the Mini-college website up early with a "Coming Soon" message about Mini-college.


Business completed; the meeting was adjourned at 3:33.


