It has become clear that dividing and delegating the responsibility of upkeep & ongoing development of the 11 individual theme gardens, will increase participation and decrease the amount of clean-up falling to a few. This end of the season event brought together many people who love the garden and sparked new creative ideas, including the use of QR technology so anyone can access identification and detailed information about individual plants and techniques.

On November 10, we will participate in our annual CGMGA Recognition Event, indoors and socially distanced, at a historic, local venue.

### Fourth Quarter 2021 Report to OMGA Board of Directors

Here in Central Oregon, we are putting our gardens to bed for the winter.

**Membership:** We continue to hold monthly Board meetings via Zoom. We were able to celebrate our Master Gardener of the Year (Nathalie Smith) by holding a surprise driveby celebration outside her house. And in the true Master Gardener spirit, Nathalie gave us a tour of her native garden.

**Community Education**: We held an extremely successful free Zoom Webinar in early October: "Putting Your Garden to Bed." Two Master Gardeners gave short presentations: one on vegetable gardens and one on perennial gardens. This was followed by a lively question and answer period. We had almost 200 registrants, with over 100 attending live. All registrants were sent a recording of the presentation. This was our most attended Webinar this year, in part because Zoom had given us a temporary upgrade to 500 participants (our license is for 100 participants).

**Plant Clinic:** We held live Plant Clinics through the beginning of October, with one shift per day from 9:00 a.m. to 1:00 p.m. While we didn't get as much walk-in traffic as we did pre-Covid, we handled many phone calls. The OSU Extension office will handle any Plant Clinic questions throughout the winter.

**OSU Extension Service Demonstration Garden in Redmond:** The last official workday was October 19, when the garden was put to bed for the winter. In addition to the usual garden maintenance this year, we planted numerous shrubs and trees in the garden area surrounding the new extension office building that finished construction in 2020.

#### **Community Gardens:**

Hollinshead and Discovery Park: The gardens were closed for the season over the weekend of October 16-17, 2021. Both coordinators reported a successful season, with few complaints from the gardeners.

<u>Waterwise Garden</u>: There is no specific closing date for the Waterwise Garden; usually it closes with our first snow (although if we have a low snow year, we will have periodic workdays throughout the winter). The water has been turned off for the season. Once the ground freezes, a layer of mulch will be applied to protect the plants over the winter. Our number one goal next year is community outreach.

**Board Retreat:** We held a Board Retreat in early October to introduce new members of the Board, and to set goals for 2022. We discussed our motto, "Teach, Support, Promote", and how these tenets guide our plans. Our priority will be community outreach. We also hope to recommence in-person events for our Master Gardener members to re-introduce the social aspect of our group. Hopefully, we can hold some outdoor events when the weather warms up.

From all of us in Central Oregon, we wish you a happy holiday season.

Our long time Horticultural agent Steve Renquist will be retiring in December after serving Douglas County for over 20 years. He will be missed but will leave with an Honorary Master Gardener badge.

# Jackson County Master Gardener's Association 4th Quarter 2021 Chapter Report

#### **Board Governance**

The Board of Directors continues to meet via Zoom on a once-a-month meeting schedule.

- The Board adopted a slate of candidates for election to the 2022 Board of Directors. Elections will be held in late October with election results announced in November. A new Board Member orientation will be held in December.
- A graduation ceremony via Zoom will be held for graduates of the 2020 Master Gardener program on October 14, 2021.
- Jackson County is under an extreme drought. All water has been shut off at the Southern Oregon Research & Extension Center. JCMGA members are working to create a rain catchment system to support water resources for next year. Current demonstration gardens are surviving at this time due to lower temperatures and remaining moisture in the soil.
- JCMGA donated a large number of native plants under propagation to the Valley of the Rogue for restoration along the Rogue River.
- JCMGA held its annual membership meeting on September 10, 2021 highlighting all organizational activities of the past year.
- Study groups specific to succulents and native plants are ongoing.
- The Plant Clinic has continued to operate online through the pandemic and recently resumed in-person services.
- Plans are underway for our annual Spring Garden Fair in 2022 which has not been held for the past two years. The Fair will be held outdoors to accommodate Covid protocols.
- Revenue continues to be generated through the bottles & cans recycling, donations through Amazon Smile, the Grange Co-op dividends, and sales of the Rogue Valley Garden Guides.
- The Board approved hiring a local bookkeeping firm to support the Treasurer.

### **Education & Community Outreach**

- The annual education day "Winter Dreams Summer Gardens" is schedule for three half days in November and will be held virtually.
- The Master Gardener Program will be a hybrid program for 2022 with modules used online in lieu of live speakers. Class size will be limited to 25.

# Lane County Master Gardener Association 4<sup>rd</sup> Quarter 2021 Report

Even though we have had many activity restrictions, Master Gardener Volunteers have found creative ways to continue our mission!! MGs have already reported over 5400 volunteer and education hours this year, as of early October.

In the month of October, the Plant Diagnostic Committee facilitated the last Show and Tell plant problem virtual presentation for 2021. Beginning in February, these one-hour Zoom meetings each had two or three Master Gardeners share a local gardening issue with audience participation help in researching the diagnosis and recommendations for treatment.

Using Covid-safe restrictions of masks and physical distancing, free compost demonstrations have resumed with a limit of 20 participants.

We also held several Soil Collection events and resumed pH soil tests with volunteers working on a solitary basis to test and send the results to clients.

Throughout the year, our Facebook Tip of the Week has kept the local gardening community engaged with timely local gardening tips, backed up with research links.

A hybrid format of a worm bin composting class will be held November 6. The classroom portion of the workshop will be online, and participants will pick up their worm bins and worms later in the afternoon that Saturday at the Extension office in Eugene.

Our Plant Clinic continues to function both remotely and in person at the Extension with physical distancing and masks. Since early September, we have transitioned to using the ECCO program for client cases. Since mid-September, 183 cases have been logged into ECCO by Lane County MG's!

#### LCMGA Master Gardener Classes/Other Local Events:

Community Garden Initiative: There has been a revival in the county community garden movement. Meetings with the county are held every other month. The discussion includes how to make community gardens better, community garden access, and the addition of new community gardens. We want to be involved in this discussion with the county and find ways as Master Gardeners to support this. Zoom meeting of interested parties are conducted every other month identifying both scope and additional meeting times. This is an ongoing effort let by a local government partner- the City of Newport- interested in increasing community garden opportunities. NO CHANGE

### Lincoln County School District (LCSD) -School Gardens Project:

LCSD's school garden program is a partnership with OSU Extension Master Gardener and Small Farms programs. Hopefully someday we will have more MG involvement when volunteering in person is allowed. This year the LCSD School Coordinator only works with the Yaquina View Elementary School. Plans are to expand the program to an additional school pending COVID restrictions. Currently our LCMGA MGs are not able to work directly with this project because of COVID restrictions. The USDA and the Whole Kids Gardening Foundation grant funding was approved for the school garden program. LCSD School Coordinator works with the Yaquina View Elementary School and Newport Middle School. COVID guidelines for garden volunteers are in the process of being developed. Mason bee cocoon cleaning classes will be held via zoom with a question-and-answer session to follow. There is also a video that can be watched at any time. On November 5 there will be a training session regarding the kind of information MG Rich Little is gathering for his research. Linn Co. MGA continues to make bee boxes of various sizes to sell each spring (see photo below) which are moderately priced, the optimum design for mason bees (many sold at stores are not designed well and encourage predators and infection) and contribute to our chapter's operating funds. Current board members have volunteered to call the members from this year and last year's roster inviting them to participate in 2022. Personal contact can be very helpful in encouraging MG's who are struggling to stay involved.

Our demonstration garden at the Linn Co. Fairgrounds (next to I 5 in Albany) produced more than 500 pounds of produce to donate to local groups. It was helpful to be able to bag up the produce in smaller quantities when delivering it to the organizations (Fish and St. Mary's Soup Kitchen). Some herbs were grown specifically to put in the bags.

The online plant clinic has been going very well. We now have an online data base, ECCO, which will be used for this purpose. Elizabeth Records will organize a training session for those interested in helping out with ECCO.
