

2023 1st Quarter Executive Committee Meeting Friday, February 3, 2023 Via Zoom, 3:00 pm

The meeting was called to order by President Chris Rusch at 3 pm. Attending were President, Chris Rusch; Eric Bosler, Past President; Janet Magedanz, Treasurer; Linda Coakley, Historian; Ann Kinkley, OMGA Newsletter; Seamus Ramirez, Database/List Serve.

The Minutes from the October 7, 2022 Executive Committee Meeting were approved. The agenda was approved.

OSU Extension Program Coordinator Report – Gail Langellotto

Gail is on leave and unavailable to attend the meeting. The Board discussed the recent developments in a change in leadership for our Master Gardener Program. Dr. Gail Langellotto has decided to return to her passion of teaching and research and will be leaving as our program advisor July 1, 2023. She will be missed by all. We are extremely grateful for her many years of service and commitment to our program. Included is a letter Gail forwarded from Dr. Lyles updating the Master Gardener program for 2023.

Dear Master Gardener Volunteers,

I write to share updates about the OSU Extension Master Gardener program for 2023.

Statewide program staffing and delivery recommendations

To support sustainable delivery of a quality, vibrant program, I charged a committee to advise on our statewide staffing and delivery model. The committee began work in August 2022 and was to deliver written recommendations by June 2023. Due to personnel transitions described below and other feedback to date, I have paused that committee's work and asked Sam Angima, associate dean for Extension in the College of Agricultural Sciences, and Bill Braunworth, horticulture department head, to assess current status and recommend next steps.

Personnel updates

Gail Langellotto, who currently serves as statewide program coordinator, has announced her decision to transition to a 100% teaching/research appointment, effective July 1. We expect that her teaching and research will remain focused on topics that are important to the Master Gardener curriculum. In addition, our faculty member who coordinates our Portland metro-area program has resigned from OSU, effective this month. We intend to move promptly to fill a position that will provide statewide program management and coordination and will conduct an expedited search to fill the regional coordinator role.

2023 program delivery

We are committed to providing 2023 Master Gardener training statewide this spring, including in our three metro-area counties (Clackamas, Washington, Multnomah). In the coming weeks, Sam will work closely with the metro-area Master Gardener associations and our faculty and staff to determine an approach to provide this opportunity in the three metro-area counties. Programming in other counties continues as planned.

2023 state legislative funding

As a reminder, OSU's Statewide Public Service Programs (OSU Extension, Agricultural Experiment Station and Forest Research Lab) have a legislative funding request of \$206 million that includes funding to sustain current service levels and new programming focused on building resilient communities, food systems and natural resources across Oregon. Community horticulture is represented in this request, and we look forward to your engagement in the legislative process.

I know that Sam and Bill are committed to keeping you informed, addressing your questions as fully as possible, and continuing to seek your input as we move the program forward together.

Thank you, again, for your commitment to OSU Extension, your dedication to this important program and your service to Oregonians.
